Mary Kunasch presented information on Augustfest and requested a donation, picnic tables, garbage cans, and two police officers to direct traffic. The city will provide two police officers, the picnic tables, and garbage cans. Mary also talked about the Celebrity Waiter Dinner at WWII and asked if the Council members would like to be waiters.

Mark Dobbertin, Waushara Youth Soccer, presented information from the past three years and asked for a donation to the program. Mayor Blaszczyk referred the request to the Park Commission.

AIRPORT COMMISSION: recommended hiring an engineering firm for the airport improvement project.

HEALTH & SANITATION: approved the CMAR; approved submitting a grant application to improve the Sewer Collection System; approved cutting of dead trees at the landfill with a permit; terminated the garbage collection contract and approved advertising for new proposals.

FINANCE & PERSONNEL: approved having Ehlers prepare the SEC report as part of their Continuing Disclosure Services; recommended payment of the monthly bills.

Moved by Grimm, second by Helbing that the claims covered by Voucher 7-01 thru 7-84 inclusive are allowed and the Clerk instructed to pay the same. Carried.
